RE: FIPPA Access Request #16-344

I am responding to your request formally received November 21, 2016, under the *Freedom of Information and Protection of Privacy Act* (FIPPA) for a copy of all records with respect to:

1. The 2017 premium rate recommendations made to the Workplace Safety and Insurance Board's (WSIB) Board of Directors (BOD) with respect to the August 2016 approval of 2017 premium rates; and
2. The 2017 revised premium rate recommendations made to the WSIB BOD and the approval of the BOD of such, in October 2016.

Access is partially granted to the records enclosed herein. The WSIB is relying on section 13 ("advice to government") of FIPPA to exempt portions of the records, as releasing the redacted information would reveal advice or recommendations made to the BOD. Please note the reliance on this discretionary exemption is in line with *John Doe v. Ontario (Finance)*, 2014 SCC 36.


